PRESIDENT'S REPORT

Ladies and Gentlemen,

It is with a great deal of pleasure that I present this, the fourth President's Report for Bowls North West Inc.

I believe that it is fair to say that this has been a year like no other with events beyond our control having a significant impact upon our Pennant Finals and the activities of our clubs, in general. The effects of the Covid-19 virus are well known and will continue to impact on our activities for some time to come. Having said that, it is most pleasing to see that all North West clubs have managed the issues in a positive manner and adhered to all relevant rules and recommendations ensuring the safety of all members and the public in general. While we look to the immediate future with a high degree of hope recent issues on the mainland have signalled the ramifications of failing to treat the virus as a continuing serious threat.

Once again this year our Board experienced personnel changes but continued to work in an effective manner achieving a number of positive outcomes. Our Ladies' Vice President, Gwenda King, was forced to resign due to health issues. Gwenda had given outstanding service to bowls at various levels over many years and we thank her for her efforts and wish her the best of health for the future.

Allison Munting agreed to step into the Vice-Presidents position and Alison Venn was added to the Board to fill the casual vacancy. Both ladies provided significant input as the year progressed.

While I do not intend to go into any detail on the financial situation, I am more than happy with our current position as will be outlined by the report from the Finance Committee. I thank Mike and his group for their responsible financial management in ensuring our ongoing viability.

Until the onset of the Covid-19 virus all competitions had been well managed by the various groups involved. During the season, all members of the Men's Match Committee elected to



resign. I thank them for their work over the years and respect their decision to resign. An interim committee was formed to finish the season and I thank Chris Benjamin, David Gamble and Dave Jeffrey for undertaking these duties.

The Ladies' Match Committee performed well as per previous years and my thanks goes out to all of these members.

The Board is proposing a change to our Constitution to enable the formation of a single Match Committee to complete the integration process. We see many positives in the formation of a single body which will be of benefit moving forward.

While the State-wide Challenge Series was not completed this season it is fair to say that the North West teams performed very well. Both Senior Ladies and Men's teams were successful in winning their respective divisions while our Open Men and Junior teams were well in contention when the events were cancelled. The vastly improved performance of our Open Ladies team was especially pleasing and augers well for the future.

One area of concern in this area is the difficulty in getting people to fill the Selectors and Coaching positions. This will be a situation to be addressed quickly by the incoming Board.

Obviously, the cancellation of the Pennant finals series was a disappointing but necessary decision. The decision to award the pennants to the ladder leaders was the only feasible outcome and I congratulate all clubs on their victories. All prize money, plaques and medals have been forwarded to the respective clubs as personal presentations were not possible at the time.

Congratulations go to all Coastal Championship winners and to the ladies Bowler of the Year winners Alison Venn (A Grade) and Doleen Backhouse (B Grade). Also, congratulations to Mark Nitz on winning the Bowls Tasmania Bowler of the Year. Well done Mark.

During the year Bowls North West was represented at all Bowls Tasmania activities including RCC Meetings and on the Junior Development Working Party. Our North West representative on the Bowls Tasmania Board, Dee Harmon, has decided not to seek re-election. On behalf of Bowls North West, I thank Dee for her service and wish her the best for the future.

As highlighted in last year's report, the Board was keen to improve communication within the bowls community. Board members met with thirteen of our clubs and documented the



proceedings and suggestions/requests from the various clubs. From the discussions arising from this document a Working Party was formed with broad terms of reference to look at the changes necessary to ensure the future viability of bowls in the area. The virus lockdown was a major setback for this group but we were recently able to hold the first meeting with some significant recommendations being presented to the Board for consideration.

The Board has decided that, after several years of discussing similar issues, it is time to act on these recommendations and will be implementing changes to the coming pennant rosters. It is intended that the Working Party will continue to meet to work towards making our sport more attractive to potential members as increasing membership numbers is the major factor in securing a viable future.

During the year members of the Board met with Bowls Tasmania Executive members, Sport and Recreation representatives and State and Federal Politicians to discuss administrative and financial issues. While the allocation of funds to regional bodies is very difficult to achieve, there are a number of options for individual clubs to receive financial assistance. We would be happy and eager to help any club preparing applications for funding future projects.

During this season we lost one of our long time stalwarts and Bowls North West Life Member, Darby Ryan. Darby was involved in bowls for over half a century and he will be missed by all of his friends and fellow bowlers.

As mentioned earlier, our finances are in good shape and one reason is the continued support of our major sponsors. To our Gold sponsors, Vincent Funeral Services and Burnie Bowls Club, a huge thank you for your valued support during this difficult period. Also, to Leanne's Trophies and Gifts and Aceit Sport for their financial support over the season. The generous support of our sponsors enables us to undertake a number of projects with confidence and to ensure that our activities continue to take place.

In her first full year as CEO Tracey Little has proven to be a very valuable asset to the Board and Bowls North West in general. I thank Tracey for her excellent work ethic and support during a difficult period.

Thanks also to our umpires, selectors and team officials for their valuable contribution to the ongoing success of our season. A special vote of thanks to Noelene Purton for her work



as a training provider for the area. This is a vital aspect of our operations and is much appreciated by the Board.

To my fellow Board members I express my sincere appreciation for your continued efforts on behalf of the bowling fraternity. In a year that threw up a number of difficult issues the Board remained positive and focused on the best interests of our sport. To Evol Kaine, who is not seeking re-election, a big thank you for your input and the best of wishes for the future.

As always, a big thankyou to all of our clubs and their members for your continued support of Bowls North West and our efforts to work for the best interest of our sport. There will be a number of changes to our Pennant Rosters over the coming season. These changes are being made in an effort to make bowls more attractive to a broader range of prospective players and increase membership levels of all clubs. I urge all bowlers to embrace the changes and help to increase numbers and ensure a strong future for our sport.

I wish all clubs, administrators and bowlers the best of fortune for the coming season and into the future.

FINANCE COMMITTEE REPORT

It gives me pleasure, on behalf of the BNW Finance Committee, to report that BNW has continued to improve its financial position due mainly to the acquisition of more sponsors for the organisation and the result of closer monitoring of expenses by the Committee and Board throughout the year.

The Finance Committee and the Board want to continue this trend in increasing our revenue base and allow us to reduce capitation fees in the very near future. Whilst capitation fees will be unchanged for 2020/21, we are very confident that reductions can start to occur for the 2021/22 season. Over the past four years we have had to purchase new uniforms for all our State-wide Challenge (SWC) sides and provide financial assistance for travel and meals for all participants and officials.

During this time it has become very noticeable to the Committee that SWC participation costs continue to rise and the Committee, with the endorsement of the Board, is in the process of arranging a meeting with the other two Regions to discuss this and other financial operational matters. BNW will continue to participate in the SWC but, as it stands now, participation costs far outweigh the prizemoney available and needs to be addressed with Bowls Tasmania as a matter of urgency.

As mentioned above the acquisition of new sponsors during the year has certainly assisted in achieving a positive result. Our thanks go out to our Gold sponsors, Vincent Funeral Services and the Burnie Bowls Club and our Bronze Sponsor, Leanne's Trophies & Gifts for their support. Of particular importance, in these uncertain times, is confirmation of their continuance in 2020/21 and again I wish to note that their support is greatly appreciated.

During the year, meetings were conducted with both Federal and State Government representatives. Unfortunately, it was confirmed that both Governments could not assist us



at that time but have alerted us to possible funding grant Programs that would be available to us in the future. We will pursue these options as they become available.

Recently, the Board approved the 2020/21 BNW Budget which includes an increased honorarium (\$18k) for our very hard-working CEO and an overall budgeted profit of \$2.3k. As mentioned previously capitation fees remain unchanged for 2020/21.

Finally, it is recommended that our Auditor, Jason Kuys from the Tax Centre, be reappointed for next year.
